<p>Rights of Crime Victims; Judges</p> <p>Creates constitutional rights for victims of crime; requires courts to facilitate victims' rights; authorizes victims to enforce their rights throughout criminal and juvenile justice processes. Requires judges and hearing officers to independently interpret statutes and rules rather than deferring to government agency's interpretation. Raises mandatory retirement age of state justices and judges from seventy to seventy-five years; deletes authorization to complete judicial term if one-half of term has been served by retirement age.</p> <p><input type="radio"/> Yes <input type="radio"/> No</p>	<p>Property Rights; Removal of Obsolete Provision; Criminal Statutes</p> <p>Removes discriminatory language related to real property rights. Removes obsolete language repealed by voters. Deletes provision that amendment of a criminal statute will not affect prosecution or penalties for a crime committed before the amendment; retains current provision allowing prosecution of a crime committed before the repeal of a criminal statute.</p> <p><input type="radio"/> Yes <input type="radio"/> No</p>	
<p>No. 7 Constitutional Revision, Article IX, Sections 7 and 8, Article X, New Section</p>	<p>No. 12 Constitutional Revision, Article II, Section 8, Article V, Section 13, Article XII, New Section</p>	
<p>First Responder and Military Member Survivor Benefits; Public Colleges and Universities</p> <p>Grants mandatory payment of death benefits and waiver of certain educational expenses to qualifying survivors of certain first responders and military members who die performing official duties. Requires supermajority votes by university trustees and state university system board of governors to raise or impose all legislatively authorized fees if law requires approval by those bodies. Establishes existing state college system as constitutional entity; provides governance structure.</p> <p><input type="radio"/> Yes <input type="radio"/> No</p>	<p>Lobbying and Abuse of Office by Public Officers</p> <p>Expands current restrictions on lobbying for compensation by former public officers; creates restrictions on lobbying for compensation by serving public officers and former justices and judges; provides exceptions; prohibits abuse of a public position by public officers and employees to obtain a personal benefit.</p> <p><input type="radio"/> Yes <input type="radio"/> No</p>	
<p>No. 9 Constitutional Revision, Article II, Section 7, Article X, Section 20</p>	<p>No. 13 Constitutional Revision, Article X, New Section, Article XII, New Section</p>	
<p>Prohibits Offshore Oil and Gas Drilling; Prohibits Vaping in Enclosed Indoor Workplaces</p> <p>Prohibits drilling for the exploration or extraction of oil and natural gas beneath all state-owned waters between the mean high water line and the state's outermost territorial boundaries. Adds use of vapor-generating electronic devices to current prohibition of tobacco smoking in enclosed indoor workplaces with exceptions; permits more restrictive local vapor ordinances.</p> <p><input type="radio"/> Yes <input type="radio"/> No</p>	<p>Ends Dog Racing</p> <p>Phases out commercial dog racing in connection with wagering by 2020. <p>No. 10 Constitutional Revision, Article III, Section 3, Article IV, Sections 4 and 11, Article VIII, Sections 1 and 6</p>	<p>City of Melbourne Referendum</p> <p>General Obligation Bonds Police Headquarters Facility Project</p> <p>Shall the City of Melbourne issue general obligation bonds to finance the property acquisition, design, construction, and equipping of a police headquarters facility, not exceeding \$35,000,000 in aggregate principal, in one or more series from time to time, bearing interest not exceeding the maximum legal rate, maturing not later than 20 years from their respective issuance dates, pledging the City's full faith, credit, and ad valorem taxing power?</p> <p><input type="radio"/> Yes - For Bonds <input type="radio"/> No - Against Bonds</p>	
<p>State and Local Government Structure and Operation</p> <p>Requires legislature to retain department of veterans' affairs. Ensures election of sheriffs, property appraisers, supervisors of elections, tax collectors, and clerks of court in all counties; removes county charters' ability to abolish, change term, transfer duties, or eliminate election of these offices. Changes annual legislative session commencement date in even-numbered years from March to January; removes legislature's authorization to fix another date.
